1 killed in Vadodara; 80 people relocated in Ahmedabad as rain continues to batter state

ONE PERSON was killed in Vadodara and around 80 people were shifted from two villages in Ahmedabad district on Sunday and Monday that were inundated after heavy rainfall. Nearly three houses collapsed in Ahmedabad, but no casualty was reported.

Under several active systems, including monsoon trough, while on Sunday Kheda and Ahmedabad were inundated, these shifted to south and central districts of Surat and Chhota Udepur, Dahod, Panchmahals and Tapi on Monday.

A 42-year-old man, identified as Vijay Vasava, was killed when a wall of a house collapsed on him in Dabhoi on Monday. Vasava had sustained head injuries, as per officers of Desar police station. A case of accidental death has been lodged as he died on the spot.

"In a few villages people were shifted from low-lying areas to safer locations. Around 40 from Badarkha village in Dholka taluka and nearly 40 in Vasna Chacharavadi in Sanand taluka were relocated. Gamdi in Daskroi taluka was also affected. Two old kutcha houses collapsed in Dhandhuka taluka and one in Sanad area, but there was no casualty. For today (Monday), the

district was under red alert," Videh Khare, District Development Officer, Ahmedabad, told *The Indian Express*.

This monsoon, a total of 4,403 people have been relocated so far — the highest of 2308 in Bhavnagar — and 691 rescued, with the highest (434) in Surat.

In Vadodara, the NH48 stretch connecting Ahmedabad to Mumbai witnessed a traffic jam on a 15-km stretch from Jambuva to Bamangam. With potholes formed on the road due to abrasion and heavy rain, the narrow bottleneck bridges became a deadlock for the slow-moving traffic. Officials of the district administration added that while the

NHAI had been directed to repair the roads the moment the rain stopped, the situation can only be improved after the widening of the bottleneck bridges to turn them into six-lane structures.

In Kheda district, several areas witnessed heavy waterlogging, forcing residents to shift from low-lying areas to safer centres. Nadiad's Gajipur, which witnessed heavy waterlogging, saw residents voluntarily shifting to a market shed area. In Thasra taluka, the access to Sandhali village was broken after a bridge was submerged, marooning about 250 persons in Patli na Muvada.

In Anand district, 26 villagers were put on alert on Monday after the Flood Warning Cell in Nadiad

issued a 'warning' for the Panam Dam, which has now recorded 80% storage at 412.23 feet — just about six feet short of its full reservoir level of 418 feet. Anand district administration alerted the villages of Gajna, Sarol, Kankapura, Nani Sherdi, Kothiya Khad, Dahevan, Badalpur and Valvod from Borsad taluka, as well as 12 villages in Ankav taluka, including Chamara, Bamangam, Umata Khadal, Kahanwadi, Amrol, Bhanpura and Navalakh.

Vadodara district recorded 21.5 mm of rainfall in 12 hours ending 6pm on Monday, with Padra, Waghodia, Vadodara taluka and Karjan receiving the maximum rainfall.

As per State Emergency Operation Center (SEOC) data, Gujarat has received 61.32 per cent of average rainfall of the season so far. In the last 24 hours ending 5 pm on Monday, 198 talukas across 31 districts received an average of 27.41 mm.

Ahmedabad Mayor Pratibha Jain, accompanied by local counsellors, visited Lambha and Vatva wards in the South zone on Monday and directed the officials to ensure speedy redressal of rain-related complaints.

Areas near Odhav fire station, Vandematram near Jagatpur, Memco Naroda, Vrindavan Heights, Vandematram Road were waterlogged on Monday.

Traffic jams were witnessed in

the worst-affected areas of Odhav circle on the Ring Road in the morning.

Ahmedabad city received 21.83 mm rainfall till 5 pm on Monday. All underpasses were open for traffic on Monday.

Opposition slams BJP

Leader of Opposition at Ahmedabad Municipal Corporation, Shehzad Khan Pathan, alleged that while the BJP talks about Olympics, cleanliness, and smart city, it has laid only 57 km of storm water lines in the last ten years, submerging Ahmedabad city every year and creating havoc during rains.

"Even during normal rainfall, there is waterlogging across the city. At present, the size of Ahmedabad city is 480.88 sq km with 3,200 km of roads. The city receives around 40 inch of rain during the monsoon season, against which the total length of storm water lines to drain the rainwater is only 965 km. Storm water lines have thus been laid only on around 25 per cent of roads, he said.

The India Meteorological Department has issued a warning of heavy rainfall for Anand, Panchmahal, Dahod, Vadodara, Chhota Udepur, Narmada, Bharuch, Surat, Dang, Tapi, Navsari, Valsad for Tuesday.

The state has been put under yellow alert till August 1.

TO MITIGATE FLOOD RISK

VMC releases water from Ajwa reservoir into Vishwamitri amid rain

THE VADODARA Municipal Corporation (VMC), which claims that the carrying capacity of the Vishwamitri river has increased to about 1,100 cumecs following a 100-day project of desilting and dredging undertaken prior to monsoon, is relying on managing the level of the Ajwa reservoir to maintain cushion in the river to mitigate the flood risk to the city.

On Monday, as rain lashed Vadodara city, the VMC continued to release water from the Ajwa reservoir into the Vishwamitri to maintain the level of Ajwa at 211 feet, especially since the catchment areas of Ajwa reservoir received 65mm of rainfall in the preceding 24 hours.

Speaking to *The Indian Express*, VMC Standing Committee Chairman Dr Sheetal Mistry said that the civic body had planned to maintain the buffer of 2.85 feet in Ajwa from 211 feet to its maximum level of 213.85, in order to be able to manage flood situation during monsoon while Vishwamitri would be maintained between 14 to 16 feet.

Mistry said, "Ajwa reservoir has different prescribed levels to be maintained during the monsoon, as per the manual. As of now, above 211 feet level, we are releasing water into Vishwamitri,

which will be allowed to go upto 14 feet. We are keeping an eye on the weather forecast while maintaining this buffer. In case of heavy rainfall in the city and in catchment areas, we will take Vishwamitri to a maximum level of 16 feet, after which we will close the gates of Ajwa if needed. But we can regulate Ajwa until it reaches 213.85 feet, following which, the release is automatic."

Mistry said that Vishwamitri's carrying capacity has increased by upto 40% as compared to 2024, which saw devastating floods in the city in August-end. "The capacity of Vishwamitri has been increased by 40% and is currently 1,100 cumecs. This would have been around 700 cumecs before desilting. So, if we look at simple math, in August 2024, Vadodara city received 12 inches of rainfall in a span of 24 hours while 12 inches of rainfall was simultaneously also received upstream. This time, due to the increased capacity, that magnitude of rainfall can be managed by the Vishwamitri river. We will also hope that there is no simultaneous heavy rainfall above 15 inches in the city and catchment areas," Mistry said.

On Monday, the level of Ajwa was recorded to be 211.72 feet at 8pm while the level of Vishwamitri was at 10.69 feet at Kala Choda — the benchmark for measuring the flood danger level of 26 feet.

Eight-foot long python rescued in Vadodara



The reptile was handed over to the Forest Department.

Vadodara: An eight-foot long python was rescued from a mango orchard in Hetampura village near Vadodara's Kelanpur area Monday, said sources. The reptile was later handed over to the Forest Department.

Earlier, a video of the python swallowing a bird at the time of the rescue was widely shared on social media. According to volunteers of the Wildlife Rescue Trust, a call was received on Monday morning from Hetampura, seeking help as a python had slithered into the duck coop on a mango orchard in the village outskirts. The members of the trust reached the spot and found the python in the duck coop, attempting to swallow the duck it had preyed upon. Following an hour-long attempt, the volunteers managed to rescue the python and hand it over to the Forest Department.

"The python was rescued by wildlife activists... a response team from the Forest Department was dispatched to rescue the reptile," Vadodara Range Forest Officer Karansinh Rajput told *The Indian Express*. "The python has now been kept under observation. It will be released into its natural habitat if no need for any treatment or intervention is found," Rajput added.
