1. We have reviewed the accompanying statement of unaudited financial results ('the Statement') of **MANCHERIAL REPALLEWADA ROAD LIMITED** (Formerly known as Mancherial Repallewada Road Private Limited) ('the Company') for the period ended June 30, 2026, being submitted by the Company pursuant to the requirements of Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('the Listing Regulations').
2. - The above unaudited financial results for the quarter ended June 30, 2026 ('the Statements') which are published in accordance with Regulation 52 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 have been reviewed by the Audit Committee and approved by the Board of Directors in their respective meetings held on July 28, 2026.
- The Statutory Auditors have carried out limited review of the financial results of the Company for the period ended June 30, 2026
- During the nine month ended December 31, 2024 Mancherial Reppallewada Road Limited (Formerly known as 'Mancherial Reppallewada Road Private Limited'), the "company" has issued listed Non Convertible Debentures (NCDs) of Face value of ₹ 100,000 each aggregating to ₹ 567.54 Crores (Series A - ₹ 330.54 Crores & Series B - ₹ 237 Crores) on private placement basis, in terms of regulation 54(2) of the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015. Series A amounting to ₹ 330.54 crores as on September 30, 2025 are secured by first charge on movable assets of the Company. Series A and Series B both are secured on pari pasu first charge basis on receivables of the Company. Further, Series A and Series B are secured by 51 % pledge over the equity interests. Series A carry interest rate of 8.08% and Series B carry interest rate of 8.28% p.a. Series A repayment has started from March 31, 2025 till September 30th, 2035 and Series B repayment has started from March 31, 2025 till March 31, 2031. The company has maintained asset cover for the Secured Non-Convertible Debentures, as of June 30, 2026. as per the requirement stated in the Debenture Documents for both principal and interest payments. There was accrued interest of ₹ 9.71 crores during the quarter ended June 30, 2026. The interest & principal on these debenture will fall due on September 30, 2026 and March 31, 2027 within next one year. For the above debenture issuances, the Company's rating for long term debt/ facilities/ debentures has been assigned at "AAA Stable by CareEdge and AAA Stable by India Ratings & Research".
- Since the Company has issued listed Non-Convertible Debentures during the quarter ended December 31, 2024, the Company started publishing it's results with the stock exchanges under Regulation 52 of SEBI (Listing Obligations and Disclosure Requirements)
- The Company has maintained asset cover as per the terms of the debenture trust deed in respect of its NCDs of ₹ 472.71 crores as on June 30, 2026.
- The company has issued redeemable non-convertible debentures. The Company has been creating Debenture Redemption Reserve (DRR) out of the profits which are available for payment of dividend for the purpose of redemption of debentures as per the relevant provisions of the Companies Act, 2013.
